### Registration

1. Click on the link for the session you would like to attend.
2. A registration window will open. Fill out the registration form. Select "Register Now" at the bottom right hand corner of the screen.
3. You will receive a confirmation email with instructions for joining the Microsoft Teams session. To add this session to your Outlook calendar, double click on the confirmation email's attachment (.ics file) and then click on Accept.

**Each registration confirmation link is unique to the participant; users cannot share or forward a link, as the system will only allow one user to log in.**

### Troubleshooting information for Microsoft Teams

Microsoft Teams issues may occur due to poor internet connection, your computer's firewall, antivirus program not allowing the connection or because you have an older version of the software that doesn't match with updated connectivity protocols.

1. Open the Microsoft (MS) Settings app by clicking on the start button. Select Settings or use the search function, go to Update and Security and select Troubleshoot. Then select Additional troubleshooters and Internet Connections. Allow troubleshooter to run and apply all changes that it recommends, then Restart the system. Open Microsoft Teams, sign in and try the meeting again.
